

## Introduction:

AVTEC is committed to providing a safe environment to allow our students to participate in training programs which support the economic growth and stability of the Alaskan economy. To this end, policies, procedures, and staffing are maintained to take every reasonable step to ensure the safety and security of individuals and property in and around the various AVTEC training, student housing, and administrative facilities. No matter how effective these actions are, however, all members of the campus community are encouraged to remain vigilant and be aware of their surroundings while practicing common sense measures to ensure personal safety. This report is created, in part, to make members of the AVTEC campus community aware of crimes that have taken place on or around the five different AVTEC campuses during the previous calendar year, so reasonable precautions can be taken to ensure the well-being of AVTEC students, staff, and the greater campus community.

## Clery Geography and Campus Facility Description:

AVTEC is a post-secondary technical training center located in Seward, Alaska, operated by the State of Alaska Department of Labor and Workforce Development. During the reporting year 2025 (January 1 – December 31, 2024), AVTEC maintained Five 'Clery Act' campuses. Statistics related to Clery Act crimes are included in this report discretely for each campus and are also separated out for on-campus student housing facilities and areas of public property contiguous to each campus.



**The First Lake Campus** is located at 703-809 Second Avenue.

**Boundaries and Description:** This campus is bordered by Second Avenue on the east, “A” Street on the south, and public land to the north and west.

A road sign directing to this campus is located on Third Avenue (Seward Highway) at C Street. This campus includes three buildings which house administrative and student training spaces. It houses most AVTEC administrative and executive offices. This building also contains training spaces for Maritime and Business Office Technology training.



- **The Building Trades Technology facility** at 709 Second Avenue is connected by a breezeway to the First Lake Facility and houses instructional offices as well as training spaces for Construction Trades Technology and Industrial Machine and Maintenance training programs.
- **The Information Technology building** at 703 Second Avenue contains instructional offices and training space for the Information Technology training program.
- **Parking lots** to support this campus are located west of the First Lake Facility and east of the Building Trades Technology Facility. Parking for staff is located east of the Information Technology building and northwest of the First Lake Facility building. Public parking is also available along the right-of-way of Second Avenue east of the First Lake Facility.
- **Public Property** contiguous with this campus is the sidewalk and right-of-way along Second Avenue, as well as First Lake Park, which is owned and maintained by the City of Seward and contains hiking trails, interpretive displays, and a picnic pavilion. Most users of First Lake Park access the property via the parking lot west of the First Lake Facility.
- This campus does not include any **Noncampus Properties**.

**The Residence Life Campus** consists of contiguous facilities at 516-519 Third Avenue, 438-440 Fourth Avenue, 505-519 Fourth Avenue, and 303 Madison Street.



**Boundaries and Description:** The campus includes the entire block bordered by Third & Fourth Avenues and Madison & Monroe Streets as well a parking lot and three multi-unit apartment buildings contiguous to this block but across Madison Street and Fourth Avenue. Private residential property borders this campus on all sides. The eight buildings on this campus contain student housing, recreation, and dining services as well as staff housing, instructional & administrative offices, and training space for the Alaska Culinary Academy. At times, dormitory rooms and student housing apartments are made available for lease to local non-profit organizations or government agencies.

- **The Willard Dunham Residence Hall** at 516 Third Avenue accommodates 112 students in 96 single and 16 double occupancy dormitory rooms. It also includes administrative offices and student recreation spaces.
- **The Fourth Avenue Dormitory** at 505 Fourth Avenue accommodates 48 students in single-occupancy dormitory rooms.

- **The Student Dining Services Cafeteria and Alaska Culinary Academy**, located at 518 Third Avenue, is connected by a foyer to the Willard Dunham Residence Hall and houses instructional & administrative offices, the student cafeteria, food storage & preparation areas as well as training spaces for the Alaska Culinary Academy.
- **The 4Plex**, located at 303 Madison Avenue, contains four two-bedroom apartments and is used for staff housing.
- **The 6/7Plex**, located at 438-440 Fourth Avenue, contains seven 2-bedroom apartments, two 4-bedroom apartments, and two 1-bedroom apartments used for student and staff housing.
- **The Student Service Center**, located at 519 Fourth Avenue, contains administrative & student support offices and recreational facilities. Most areas of the first floor of the Student Service Center are leased for parts of the week to the City of Seward Department of Parks and Recreation, which maintains an administrative office and facilitates public access to the facility.
- **Parking lots** for student and public use are at the southeast and southwest corners of Fourth Avenue and Monroe Street. A parking lot for residents of the 6/7Plex apartments is at the southeast corner of Fourth Avenue and Madison Street, and parking is available for 4Plex residents on the north side of that building. A parking lot for staff and visitors is at the southeast corner of Third Avenue and Monroe Street. Parking areas for staff and state vehicles are in the driveway west of the Willard Dunham Residence Hall and the Student Dining Services Cafeteria and in the alley between the Willard Dunham Residence Hall and the Student Service Center. Parallel parking is available in the rights-of-way of Third and Fourth avenues in front of the Willard Dunham Residence Hall and the Student Services Center. Pull-in street parking is located along Fourth Avenue and Madison Street on the east and south sides of the Fourth Avenue Dormitory.
- **On-Campus Student Housing** facilities consist of the Willard Dunham Residence Hall (516 Third Avenue), the Fourth Avenue Residence Hall (505 4<sup>th</sup> Avenue), the 4Plex (303 Madison Street), the 6Plex (438 Fourth Avenue), and the 7Plex (440 Fourth Avenue).
- **Public Property** contiguous to this campus is the north/south alley between Madison & Monroe Streets and Third & Fourth Avenues, along with sidewalks and right-of-ways along Madison & Monroe Streets and Third & Fourth Avenues contiguous to and between the facilities on this campus. The first floor of the Student Service Center is also considered public property.
- This campus does not include any **Noncampus Properties**.

**The Port Avenue Campus** is located at 808 Port Avenue.

**Boundaries and Description:** It is bordered by Port Avenue on the south and by private property on all other sides. This campus includes one building and a secure fenced storage yard north of the building. It also contains an administrative office leased to the State of Alaska Division of State Parks. This campus houses instructional offices and training spaces for Refrigeration and Plumbing & Heating training.

- **Parking** for students, staff, and visitors is available in a parking area south of the building.
- **Public Property** contiguous to this campus is the sidewalk and right-of-way of Port Avenue along the south side of this campus.
- This campus does not include any **Noncampus Properties**.



**The Applied Technology Campus** consists of contiguous facilities located at 1900 & 1912-1916 Leirer Road and 1906 Alameda Road.

**Boundaries and Description:** This campus is bordered by Alaska Railroad Property on the north, east, and west and by private properties on Leirer Road and Alameda Street to the south. It includes three buildings within a large secure fenced area and a building maintenance shop across Alameda Road. Within the fenced areas there are several storage containers and a large-scale wind turbine used for Industrial Electricity training.



- **The Industrial Electricity building** is located entirely within the secure fenced area at 1912-1916 Alameda Road and includes instructional offices and training spaces for Industrial Electricity, Bulk Fuel Operations, and Power Plant Operator training.
- **The Diesel Heavy Technologies building** is located at 1906 Alameda Road and includes administrative & instructional offices and training space for Diesel Heavy Equipment Technologies training. This building is accessible along Leirer and Alameda Roads, and its rear is within the fenced area.
- **The Applied Technologies building** is located at 1916 Leirer Road and includes administrative & instructional offices as well as training spaces for Industrial Welding, Bulk Fuel Operations, and Power Plant Operator training. This building is accessible along Leirer Road, and its rear is within the fenced area. This building also includes equipment and supply storage for building maintenance as well as training supplies & equipment that need to be stored indoors.
- **The AVTEC Building Maintenance shop** includes administrative offices and spaces for building maintenance staff and supplies, along with a fenced storage yard. This building is not accessed by students.
- **Parking** for students is available on Alaska Railroad Property across Leirer Road from the Diesel Heavy and Applied Technology buildings and adjacent to the Industrial Electricity building inside the fenced area. Parking for staff and visitors is available along the west side of the Applied Technology building, the south side of the Diesel Heavy building, the west side of the Industrial Electricity building, and the west side of the Building Maintenance shop.
- **Public Property** contiguous to this campus is the unpaved rights-of-way for Leirer and Alameda roads. There are no sidewalks in this area.
- This campus does not include any **Noncampus Properties**.

**The Maritime Safety Training Center Campus** is located at 3504 Jellison Ave.



**Boundaries and Description:** This campus is situated on a large lot owned by the City of Seward and is bordered by Jellison Avenue to the south, undeveloped parts of Delphin and Mustang Avenues to the north, and vacant parcels owned by the City of Seward to the east and west. A road sign directing to this campus is located on the Seward Highway at Nash Road. The areas used by AVTEC are surrounded by a fence. This campus contains a single building with training spaces for fire training, one enclosed

and one open-air fire simulator used in maritime, bulk fuel operator, and power plant operator training, and a fixed lifeboat davit used for maritime training.

- **Parking** for users of this campus is located inside the fenced area.
- **Public Property** contiguous to this campus is the unpaved rights-of-way for Jellison and Delphin streets, the undeveloped right of way for Mustang Avenue, and a large vacant parcel owned by the City of Seward.
- This campus does not include any **Noncampus Properties**.

During the training year, the average student population across all campuses is approximately 125 students (varying with the dates and enrollment of short-term classes).

## Law Enforcement:

AVTEC does not maintain or employ any sworn campus law enforcement, security services or employees. Law enforcement on all AVTEC Campuses is provided by the City of Seward Police Department. Data and statistics kept and provided for this report by the Seward Police Department may not perfectly align with internal AVTEC documentation. The Alaska State Troopers have concurrent jurisdiction over certain crimes within the Seward city limits, but do not regularly take a primary role in criminal investigations related to AVTEC campuses. The only AVTEC campus open and supported by staff during non-business hours is the Residence Life Campus, where AVTEC's student housing is located. Overnight staff on this campus have no law enforcement certifications or responsibilities but maintain a close professional relationship with the Seward Police Department.



AVTEC staff are not charged with enforcing federal, state, or local laws. Staff members who suspect or have knowledge of a violation of law will report the potential violation to the Seward Police Department, which has jurisdiction over all geographic campus boundaries.

## Annual Report of Campus Crime Statistics:

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act mandates a report be produced and made available annually for release to current and potential students and members of the greater campus community. Under the Clery Act, only data related to certain criminal offenses is collected. These crimes are Murder/Non-Negligent Manslaughter, Sex Offenses (including Rape, Fondling, Incest, and Statutory Rape), Robbery, Aggravated Assault, Burglary, Motor Vehicle Theft, and Arson. Additionally, if any of the above crimes or any other crime involving Larceny/Theft, Simple Assault, Intimidation, or Destruction/Vandalism is classified as a hate crime (using updated categories from the most recent HEA / Clery Act legislation), it will be included in the report. Arrests or referrals for campus disciplinary action related to illegal weapons possession or violation of drug and alcohol laws will also be included in the report, but only those incidents considered criminal and not those in which an individual only violated a campus policy. Data



related to Violence Against Women Act crimes (including incidents of Domestic Violence, Dating Violence, and Stalking) is also included.

In accordance with the Clery Act, crimes committed on AVTEC property or on public property contiguous to AVTEC property are included in these statistics when geographic location can be determined by the Seward Police Department. To facilitate better understanding of the statistics, data is reported for each of AVTEC's five campuses and on-campus student housing properties discretely. For this year's report, the Seward Police Department has provided statistical data for crimes reported on AVTEC campuses and their contiguous public property. Data in this report was also compiled by AVTEC staff following policies and procedures related to reporting as set by the Clery Act and AVTEC policy. Because most of the personal data used to generate reports by both AVTEC staff and the Seward Police Department are confidential, these data sets may or may not overlap, so the statistics provided by the Seward Police Department are provided separately from the data accumulated by AVTEC staff.

In accordance with the Clery Act, the AVTEC Annual Safety and Security Report, with statistics for the 2024 calendar year is published on the AVTEC website before October 1<sup>st</sup>, 2025. This report will be sent via email, before October 1, 2025, to all students, staff, and faculty at AVTEC. Hard copies of this report are available at the AVTEC Business Office at 809 2<sup>nd</sup> Avenue in Seward. A copy will be mailed by USPS or electronically via email upon request by contacting the admissions office at 1-800-478-5389.

## **Timely Warnings and Campus Community Notification:**

Timely Warnings are issued to the campus community in the event of a situation affecting an AVTEC facility that, in the judgment of a member of the AVTEC Administration or a Department Head, constitutes a threat to the student body or campus community. Timely Warnings are issued by the AVTEC Administration. Timely warnings, by definition, are issued as soon as possible after a potential danger to the community is identified. Notifications are distributed through similar methods once the 'All Clear' has been issued by the Incident Commander. Depending on the campus involved and the type of incident, a Timely Warning can be made by using voice announcements, electronic devices, social media, the campus telephone system, email, social media, or posted notices.



In compliance with the Higher Education Opportunity Act, AVTEC has created a communications plan to provide students, staff, and members of the greater campus community with notification in the event of emergencies, threats, or alerts requiring the warning of others in the area. This communications system involves a variety of methods of spreading information about a threat to the community, including a campus-based intranet system, campus email and telephone systems, public electronic bulletin boards, megaphones, signage, word of mouth and public bulletin boards. AVTEC staff also utilize various social messaging platforms and an opt-in text messaging system to electronically notify members of the campus community in the event of an emergency.

If a situation warrants notifying the campus community to practice different levels of caution, evacuation, or other actions, a member of the AVTEC Administration will notify the campus community of crimes or other incidents on or around any of the campuses requiring action. The campus community is immediately notified by a Timely Warning when a significant emergency, situation, or serious threat of harm is present, so long as this notification does not compromise staff or law enforcement activities to contain the incident.

### **Responding to a Crime-in-Progress:**

1. Members of the AVTEC campus community who observe a crime-in-progress should not attempt to arrest or stop the incident except in cases of self-defense.
2. When a member of the AVTEC campus community observes a crime, they are encouraged to take a photograph of the scene to share with law enforcement.
3. Individuals who observe a crime are encouraged to call 911 and provide the dispatcher with their name and physical location. The reporter is encouraged to wait at the location until police arrive. If it is not safe, provide the dispatcher with contact information.
4. In the event of an emergency, members of the AVTEC campus community will continue as much as possible with their usual activities. If the incident is taking place outside, avoiding doors and windows is encouraged.
5. Members of the AVTEC campus community should not interfere with individuals making a disturbance or with law enforcement personnel.
6. Members of the AVTEC campus community who are not involved in a criminal incident but are unsure what action to take, should shelter-in-place where they are and call 911. If the location is not safe, they should find a safe place as quickly as possible and remain in that location until being given the 'all-clear' by law enforcement.
7. After notifying 911, members of the AVTEC campus community who witness a crime should contact the Residence Life 24-Hour Cellphone (907-362-1645) to report the incident.
8. When a member of the AVTEC campus community is the victim of a crime:
  - a. Do not resist the actions of the perpetrator except in cases of self-defense.
  - b. Wait until the perpetrator leaves before calling for help.
  - c. Make every attempt to get a good description of the perpetrator. Writing down the description as soon as possible is a good method to maintain a clear recollection.
  - d. Take reasonable steps to secure the crime scene and ask other witnesses to remain until the police arrive.

### **Reporting a Crime:**

Members of the AVTEC campus community are encouraged to report all crimes and public safety-related incidents that occur in or around AVTEC facilities to the Seward Police Department or any AVTEC staff member in a timely manner. Prompt reporting of all crimes ensures accurate Timely Warning notices and disclosure of crime statistics. Any AVTEC staff member on duty can help a victim access 911 or non-emergency police contacts to make a report at any time of the day or night.

**Anonymous Reporting of a Crime:** Anonymous reporting of crimes is available by contacting an AVTEC Counselor. Victims of a crime who do not want to pursue action with the criminal justice system are encouraged to make an anonymous disclosure of the incident to an AVTEC Counselor for crime statistics reporting purposes. An AVTEC Counselor can file a report with details of most incidents without revealing

the identity of the individuals involved, upon a specific request for anonymity. The purpose of an anonymous report is to comply with a crime reporter's wish to keep the matter confidential, while taking steps to ensure the safety of the AVTEC campus community. With such information, AVTEC will be able to keep an accurate record of the number of criminal incidents on and around campus, determine where there is a pattern of crime related to a particular location, method, or assailant, and alert the campus community to potential dangers. Reports filed in this manner are included in the annual crime statistics for AVTEC based on their geographic location.

Crimes that take place in Seward should be reported to the Seward Police Department (911 or (907) 224-3338). AVTEC Counselors encourage students to report crimes on an anonymous basis for inclusion in the annual crime statistics if they are unwilling to report them to the criminal justice system. In accordance with federal and state laws, AVTEC counselors cannot honor a request for anonymity when informing law enforcement about a crime involving the abuse of minors, elders, or vulnerable adults, threats of harm to self or others, or when disclosure is required by court order or subpoena.

All members of the AVTEC campus community are encouraged to report any criminal or suspicious activity to the Seward Police Department and the Residence Life office. Prompt reporting ensures the accurate dissemination of Timely Warning notices on campus and disclosure of crime statistics. AVTEC maintains a professional working relationship with the Seward Police Department as well as the Alaska State Troopers and refers all non-anonymously reported crimes and related incidents to law enforcement regardless of the location they occur.



## **Campus Security and Medical Response Services:**

All five AVTEC campuses are within the jurisdiction of the Seward Police Department which is responsible for law enforcement on and around all campus properties. All five AVTEC campuses are within the service area of the Seward Volunteer Ambulance Corps who provide advanced life support and emergency transportation when activated through the 911 system.



Many AVTEC staff members are trained in CPR and first aid and can provide first responder medical attention to individuals in need in or around AVTEC facilities. AEDs (automated external defibrillators) and first aid kits that include Narcan for response to opioid overdose are available at several locations around every AVTEC campus. Many AVTEC staff are trained in Mental Health First Aid and crisis de-escalation techniques to assist students who are experiencing mental health emergencies in accessing healthcare resources.

AVTEC staff members will arrange for transportation using either AVTEC vehicles or the Seward Volunteer Ambulance Corps to allow

injured or ill students, staff, or visitors to access medical care available at the 24-hour Emergency Room in Seward.

### **Access to Campus Facilities:**

The AVTEC Business Office, Administration Office, and academic department offices are open to the public during regular business hours (typically 8:00 AM - 4:30 PM Monday-Friday).

During non-business hours, access to all non-Residence Life areas of AVTEC campuses is restricted to staff only.

Training spaces are open during business hours to students, invited guests, and escorted visitors with prior permission from the facility Department Head or a member of the AVTEC Administration. Visitors to hazardous areas or student labs must wear personal protective equipment necessary in those areas.

Residence Halls are open to residents and escorted guests over the age of 18 from 7:00 AM - 10:00 PM daily and to residents only from 10:00 PM - 7:00 AM daily. Unescorted, under 18 without a parent/guardian, or overnight guests are not permitted in Residence Halls.

Student Housing Apartments are open to residents and their guests 24 hours a day. Overnight guests in Student Housing Apartments are permitted but must have prior permission from the Residence Life office. Overnight guests in Student Housing Apartments are permitted for a maximum of 7 nights.

Residence Halls are locked, and access is restricted to staff only during summer and winter training breaks when training is not in session and the buildings are not occupied by residents.



The first floor of the Student Service Center is open to the public during posted business hours of the Seward Department of Parks and Recreation. Depending on the City of Seward policies, members of the public may be required to pay an access fee to use the facility. The second floor of the Student Service Center is open to the public only during special events. The entire Student Service Center is open to Residence Hall residents 24 hours a day and to students living off-campus or in Student Housing Apartments from 7:00 AM – 10:00 PM daily. Certain facilities inside the Student Service Center may have other access restrictions, which are posted (e.g., private offices, sauna, library).

Emergencies, holidays, and special events may necessitate changes or alterations to posted schedules. Any changes to traditional schedules are posted at building entrances and shared via social media.

### **Residence Life and Student Housing:**

During the period covered in this report (January 1, 2024 – December 31, 2024), the Residence Life Department was covered 24 hours a day / 7 days a week when students were present in the Residence Halls. On rare occasions, due to personnel limitations, staffing of the Residence Life campus was provided remotely

during isolated periods. Residence Life Attendants are the primary staff responsible for assisting residents on all AVTEC campuses during non-business hours. Residence Life Attendants serve as a resource for residents, enforce campus rules and policies, help to mediate personal conflicts, respond to emergencies, and make reports of incidents on campus to the AVTEC administration. Residence Life Attendants make regular rounds of the entire Residence Life Campus and are responsible for the day-to-day operation of Residence Halls, Student Housing Apartments, and the Student Service Center during hours when it is not open to the public.

## **Guest Policy:**

Guests in AVTEC Residence Halls must be over the age of 18 (or accompanied by a parent/guardian) and always escorted by a Residence Hall resident. Unescorted guests are asked to leave the campus. Individuals who are not Residence Hall residents are not permitted to remain in a Residence Hall room overnight.

When escorted by a resident, guests are permitted in and around Residence Halls during non-quiet hours (7:00 AM – 10:00 PM). Violating a suite-mate's right of entry or hindering another resident's ability to study, sleep, bathe, or to their right of personal space are considered violations of the Student Code of Conduct. Residents are held responsible for the actions and activities of their escorted guests in and around the Residence Halls.

Overnight guests are permitted in Student Housing Apartments with prior permission from the Residence Life Department Head. The behavior of guests in Student Housing Apartments is the responsibility of the student-tenant. Overnight guests are permitted for a maximum of 7 nights with prior approval from the Residence Life office.

Residents found violating Guest policies or the Student Code of Conduct are subject to the loss of their guest privileges, or other student discipline, up to and including eviction, at the discretion of the AVTEC administration.



## **Missing Student Procedure:**

Members of the AVTEC campus community who suspect a student has been missing for over 24 hours or might be in imminent danger should report their concern to their instructor, a counselor, or a Residence Life Attendant. Each student must list a confidential emergency contact person to be notified in case the student is determined to be missing. Only authorized campus officials have access to this emergency contact.

If a student is reported missing, local law enforcement will be contacted even if the student lists a confidential contact. If the individual reported missing is under 18 years of age, an AVTEC representative will also attempt to contact their parent or guardian.

A Residence Life Attendant may enter a student's on-campus living assignment without prior notice to attempt to locate a missing student. They will knock and loudly announce their intentions to enter the room before unlocking or opening the door.

### **Student Housing Contact:**

The Residence Life Office is located at 516 3<sup>rd</sup> Avenue (Willard E. Dunham Residence Hall), Room 103. During times when there are students living in either student Dormitory, Residence Life staff can be reached 24 hours a day at (907) 224-6100 or (907) 362-1645.

### **Security and Safety Aspects of Maintenance:**

AVTEC Campus spaces are well illuminated and maintained. AVTEC custodial and maintenance staff continually check for safety hazards on campus. Improvements to area lighting and mitigation of safety hazards are made on an ongoing basis when problem areas are observed. Areas revealed as problematic by students, faculty, staff, or other members of the AVTEC campus community will have security surveys conducted to develop a plan to mitigate the issue(s). The AVTEC Operations team and outside organizations such as the Seward Police Department, the Seward Volunteer Fire Department, and the City of Seward Building Department will be involved if deemed necessary or helpful. These surveys identify safety or security issues, including landscaping, locks, alarms, lighting, and communications. Additionally, the AVTEC Operations Team meets periodically to discuss security and safety issues of concern.



All students are encouraged to report any unsafe situation as soon as possible to their instructor, a counselor, or the Residence Life Attendant. Snow and ice removal, tripping hazards, and other transient or ongoing issues reported to any AVTEC staff member are investigated promptly. If necessary, access to areas constituting a danger or safety concern is restricted until the safety or security risk can be resolved.

### **Crime Prevention Efforts:**

Throughout the year, actions are taken to best ensure the safety and security of the AVTEC campus community. During orientation sessions, all students are provided with information related to personal safety and security. Students are informed of health and safety resources available on campus and the Seward community. Details about crime patterns on campus and in surrounding neighborhoods are shared and students are encouraged to review the Annual Crime Report. Crime and sexual assault prevention programs are offered at the annual community health fair held in the Student Service Center. All students are made aware of ways to speak with a counselor on a confidential basis regarding crime and personal issues.

A common theme of all awareness and crime prevention programs is to encourage students and employees to be aware of their personal responsibility for their security and the security of others. This includes reminders to lock doors and windows, use caution in darker areas of the areas around campus while walking

alone at night, and to avoid keeping or displaying large amounts of cash & valuables. Members of the AVTEC campus community are encouraged to always maintain a general situational awareness of their surroundings.

When time is of the essence, information related to crime prevention and personal safety is shared with the AVTEC community through Timely Warnings, security alert notices posted around campus, email, the intranet, public video displays, and other methods—including word of mouth from staff

### **Alcohol Policies:**

AVTEC maintains a zero-tolerance policy for the possession of alcoholic beverages on AVTEC property. This policy includes empty containers of beverages, including alcohol.



Any student found in possession of alcoholic beverages, or any student over the age of 21 who provides alcohol to someone under 21 on AVTEC property, will be documented as a policy violator and will be subject to disciplinary sanctions.

AVTEC notifies the Seward Police Department if staff become aware a student under 21 possesses or is under the influence of alcohol, or if a student over 21 has provided alcohol to someone under 21 on AVTEC property.

Students found on campus intoxicated by alcohol are subject to disciplinary sanctions. Intoxication is determined by behavior and objective signs (i.e., smell of alcohol and behaviors indicating intoxication). Students who refuse to cooperate with staff inquiries when there is reasonable suspicion of intoxication are documented as policy violators. Such incidents are subject to the same sanctions as cases where intoxication has been objectively confirmed.

### **Illegal Drug Policies:**

AVTEC maintains a zero-tolerance policy for the possession, use, manufacture, or sale of illegal drugs on AVTEC property. Illegal drugs are street drugs or prescription medications being used without a prescription. This policy includes cannabis and products containing cannabis derivatives intended to cause intoxication as well as paraphernalia and items designed solely to use or store substances included in this policy. This policy differs from Alaska State Law, which allows the possession, by adults over 21, of cannabis and related products in private housing facilities.

While Alaska state law permits cannabis use by individuals over 21 in private residences, AVTEC prohibits the possession or use of cannabis on campus property. Violations by students over 21 are addressed through disciplinary sanctions rather than law enforcement referrals.

AVTEC notifies the Seward Police Department if staff become aware that a student is using, possessing, selling, or manufacturing illegal drugs, is under the influence of illegal drugs, or poses a danger to themselves or others on campus.



Students found to be in non-compliance with the Illegal Drug Policy are subject to disciplinary sanctions. Students who refuse to cooperate with staff inquiries when there is a reasonable suspicion of being under the influence of illegal drugs are documented as policy violators. Such incidents are subject to the same sanctions as cases where intoxication has been objectively confirmed.

A student in violation of this policy does not need to be intoxicated by illegal drugs, only under their influence, in possession, or attempting to sell or manufacture illegal drugs, including cannabis on AVTEC campus property.

### **Substance Abuse Intervention and Education:**

Students with pre-existing alcohol or drug problems are strongly encouraged to obtain professional treatment before matriculating at AVTEC. There are limited resources for substance abuse treatment available within the community of Seward. For students working to overcome a substance abuse problem, Alcoholics Anonymous and Narcotics Anonymous group meetings are typically available locally on a daily or weekly basis. Residence Life or Student Services staff will assist students to confidentially access these resources. AVTEC Counselors are available to provide education, support, and referral assistance to connect those in need with available community resources.

Substance abuse support services and referrals for treatment are also available from AVTEC counselors who maintain offices on the Residence Life campus.

### **Weapons Policy:**

Members of the AVTEC campus community are not permitted to possess, use, or display weapons on AVTEC property. This includes, but is not limited to, firearms, ammunition, explosives, knives with blades over 3 1/2 inches, switch or gravity blade knives, and other items reasonably considered weapons. This policy includes the display of pellet, air, replica, or toy guns designed to accurately resemble an actual weapon. Culinary knives used for training and household knives inside kitchen areas of Student Housing Apartments are exempt from this policy. Individuals who observe a weapon on campus should immediately contact the Seward Police Department by calling 911. AVTEC staff refer all such incidents directly to law enforcement.

Any student found to be possessing an item in violation of this policy will be documented as policy violators and subject to disciplinary sanctions.

### **Gambling Policy:**

Gambling without a permit from the State of Alaska Department of Revenue is prohibited on AVTEC property. This includes raffles, lotteries, sports betting, and card games for money. Gambling with a permit

from the State of Alaska Department of Revenue may only occur with explicit written permission from the AVTEC Director or their designee.


### **Sex Offender Registration:**

The State of Alaska maintains an online database of individuals convicted of sex offenses in Alaska since January 1, 1999. Individuals can search this database by geographic region or by name. This database is available at [sor.dps.alaska.gov/Registry/Search](http://sor.dps.alaska.gov/Registry/Search). This website address is published in the student handbook and made available by AVTEC Counselors upon request.

AVTEC staff cooperate with law enforcement personnel as requested to ensure all members of the campus community required to be in this registry are compliant with the law.

### **Sex Offenses:**

Students accusing another student of a sexual offense are made aware, through a meeting with their counselor and in writing, of their rights during the disciplinary process. This includes the right to anonymity and not involve the criminal justice system, the availability of changes to their academic, housing, transportation, and working situations, and the right to be present with an advisor for all judicial or disciplinary hearings throughout the process, regardless of the involvement of the criminal justice system.



Students making an accusation are informed, in writing, of resources available to them, including physical & mental health services, victim advocacy, and legal assistance from AVTEC and other community-based resources.

When a student makes an accusation against another student of a sexual offense, immediate steps are taken to provide safety and security to all students involved. Reasonable protective measures may include moving the accused or accuser to a different housing location, the provision of a Leave of Absence for the accused or the accuser, or the temporary restriction of the accused individual from certain activities or areas of the campus.

Individuals who are a victim of a sexual offense are encouraged to seek assistance from a Domestic Violence / Sexual Assault program.

If an AVTEC employee is made aware of a sex offense committed in or around an AVTEC facility or upon an AVTEC student, they will take action to ensure the safety and security of all members of the AVTEC campus community.

- In the event of a sex offense, the safety of the victim is of paramount concern. If an AVTEC staff member suspects imminent danger, they will activate the 911 system.

- If an AVTEC staff member becomes aware of a sex offense, they will encourage the victim to obtain necessary medical treatment at the emergency room. If requested and appropriate, they can arrange for emergency transportation or provide transportation to the emergency room in an AVTEC vehicle.
- If an AVTEC staff member becomes aware of a sex offense, they will encourage the victim to preserve evidence of the offense. Staff will encourage the victim to avoid taking a shower or washing clothing worn during the offense.
- If an AVTEC staff member becomes aware of a sex offense, as soon as possible they will contact the AVTEC Student Services Department to start the process of responding to the incident. If the Title IX coordinator or one of the Counselors is not reachable, then the staff person should contact the Residence Life Attendant on duty who can notify the Title IX Coordinator.

If a victim of a sex offense decides to not report the crime to law enforcement, the AVTEC Title IX Coordinator or Counselor will document the incident without personal identifying information for the purpose of including it in the annual Crime Statistics Report.

Most AVTEC staff are mandatory reporters and are required to notify the Title IX Coordinator when they become aware of any sex offense on campus or involving a student. Any AVTEC staff member interacting with a victim of a sex offense will encourage the victim to speak with an AVTEC counselor, Title IX Coordinator, or a representative of a local DVSA program, and to report the crime to the local police department.

Sexual harassment and violence offenses occurring on AVTEC property are serious infractions of student conduct and are thoroughly investigated when reported. Students found to have committed a sexual offense are documented as policy violators and be subject to AVTEC disciplinary sanctions and are referred to the criminal justice system if the reported offense was not made anonymously. Dating violence, domestic violence, sexual assault (including rape, fondling, incest, and statutory rape) and stalking of any member of the AVTEC campus community is not tolerated and every accusation related to any of these offenses is treated seriously by all AVTEC staff members. All AVTEC Staff and long-term students participate in a Title IX training on an annual basis.

### **Emergency Contact:**

In an emergency requiring Police, Ambulance, or Fire services, members of the AVTEC campus community on or around any AVTEC campus should call 911 immediately.

Individuals who want to reach an AVTEC staff member during business hours can contact the AVTEC First Lake Facility Business Office at (907) 224-3322 or 1-800-478-5389. During non-business hours, they can contact the Residence Life Attendant on duty at (907) 224-6100 or (907) 362-1645.



### **Daily Security Log:**

The Residence Life Department maintains a crime log for all AVTEC campuses in Seward. This log documents all Clery Act reportable crimes in and around AVTEC facilities and is available to the public. The Crime Log can be viewed upon request at the Residence Life Office at 516 3<sup>rd</sup> Avenue, room 103, Seward.

### **Fire Log:**

The Residence Life Department maintains a fire log for all AVTEC campuses in Seward. This log documents all fires in and around AVTEC facilities and is available to the public. The Fire Log can be viewed upon request at the Residence Life Office at 516 3<sup>rd</sup> Avenue, room 103, Seward.

### **Student Conduct and Discipline:**

All AVTEC students are expected to comply with the policies and procedures published in the AVTEC Student Handbook which is provided to all students at orientation and available on the AVTEC public website. Information about student conduct, grievance procedures, and disciplinary sanctions are available in the handbook as well as on the AVTEC website at [www.avtec.edu](http://www.avtec.edu).

### **Other Reportable Offenses and Incidents - Hate Crimes:**

The Clery Act requires the collection of specific data from events that are reportable under the Act, and any other crime involving bodily injury that manifests evidence the victim was intentionally selected because of the perpetrators' bias. The recognized categories of bias include race, gender, religion, sexual orientation, ethnicity, national origin, and disability. Statistics related to crimes fitting this description are submitted discretely by the campus as a part of the Annual Crime Report.

During calendar years 2008 – 2020 and 2022-2024 (Clery Act reporting years 2009 – 2021 and 2023 - 2025) no incidents manifested evidence of a hate crime in or around any AVTEC campus. During calendar year 2021 (Reporting year 2022), an incident of religion-related vandalism in Two Lakes Park (Public property contiguous to the First Lake Facility Campus) was documented by the Seward Police Department. The perpetrator was never determined.

### **Other Reportable Offenses and Incidents - Fires:**

During the calendar years 2020 - 2024 (Clery Act reporting years 2021 - 2025) there were no incidents of fires on any AVTEC campuses in Seward.

## AVTEC Hazing Transparency Report

In January 2025, the Stop Campus Hazing Act (SCHA), an amendment to the Clery Act, took effect. This law prioritizes prevention and transparency regarding hazing at post-secondary institutions. SCHA requires post-secondary institutions, including AVTEC, take steps to prevent and report incidents of hazing on and around their campuses.

AVTEC does not sponsor or officially recognize student groups or clubs. While informal student gatherings occur, they are not monitored or sanctioned by AVTEC. Any incidents of hazing reported in connection with such informal gatherings are addressed under the AVTEC Student Code of Conduct and investigated in accordance with the Campus Hazing Policy.

### AVTEC Campus Hazing Policy:

The 2025–26 AVTEC Student Handbook includes the following under Behavioral Misconduct: *“Hazing includes any act that endangers the mental or physical health or safety of a student, or that involves the forced consumption of alcohol, drugs, or other substances for the purpose of initiation, affiliation, or admission into any group or organization, regardless of the student’s willingness to participate. Hazing is strictly prohibited, is a violation of AVTEC policy, and may also be a violation of state law. Reports of hazing will be investigated in accordance with AVTEC’s student conduct procedures. If a report results in a formal finding of a policy violation or a legal conviction, it will be documented and publicly disclosed as required by federal law. Students who experience or witness hazing should report it immediately. Reports can be made to the AVTEC counselor, the Title IX Coordinator, Residence Life staff, an instructor, or Department Head. In accordance with federal law, AVTEC publicly discloses any hazing incidents that result in formal disciplinary action or criminal conviction. A list of such incidents can be found on AVTEC’s website.”*

### Prevention Efforts:

For the 2025–26 training year:

- All staff were informed of the AVTEC Campus Hazing Policy at the staff in-service held on August 7, 2025.
- Students are informed of the hazing policy at Orientation, including a clear statement that hazing is prohibited and subject to discipline. All students receive a copy of the student handbook, including the AVTEC Campus Hazing policy.
- Flyers and educational materials on hazing prevention are periodically distributed across campus.

### Transparency Reporting:

Starting in December 2025, and twice annually, AVTEC will release a Campus Hazing Transparency Report documenting:

- Names of student organizations found responsible for hazing
- A description of the violation
- Relevant dates of the incident, investigation, and findings

**State Context:**

Alaska does not have a specific hazing statute, but incidents of hazing by members of the AVTEC campus community may be prosecuted under assault, battery, or reckless endangerment laws.

**Investigations and Appeals:**

Reports of hazing initiate an investigation. Findings of responsibility may be appealed under the Student Handbook; the appeal officer's decision is final.

**2025 Hazing Incidents Reported:**

For the calendar year 2025, from January 1, 2025, through December 31, 2025, there have been ZERO incidents of hazing reported on any AVTEC campus property or involving any members of the AVTEC student body to AVTEC staff members.

## **AVTEC Annual Fire Safety Report**

### **Summary:**

AVTEC maintains a fire-safe campus by identifying and eliminating fire hazards through annual and ongoing inspections as well as emphasizing compliance with fire and building codes. All fire protection systems are inspected, maintained, and tested as required under the supervision of the AVTEC Facility Maintenance Foreman and the City of Seward Fire Chief and Building Official.

Fire drills are not required by the State of Alaska or the City of Seward building code and are not conducted in any AVTEC facility.

### **Student Housing:**

All Residence Halls are equipped with monitored fire and smoke alarms & fire suppression systems. In the event of an alarm, the Seward Volunteer Fire Department is notified by the alarm monitoring company and will respond. All AVTEC Residence Halls and apartment buildings meet current fire protection codes. Fire and smoke alarms and sprinkler systems are inspected annually by certified inspectors.

All Student Housing Apartments are equipped with hard-wired and battery-operated smoke detectors. One Student Apartment building with a common entrance (The 4Plex at 303 Madison St, Seward) and one Student Apartment building with a fire curtain sprinkler system (The 7Plex at 438 Fourth Ave, Seward) are remotely monitored by an alarm monitoring company. In the event of an alarm activation in the 4Plex or a sprinkler activation in the 7Plex, the Seward Volunteer Fire Department are notified by the alarm monitoring company and will respond.

### **Fire Safety Education and Training:**

During orientation, all students are informed of building evacuation procedures, emergency gathering points and evacuation shelters in the community. Students are also informed of fire suppression equipment and locations of alarm pull stations. Fire alarm 'drills' are not required or conducted on AVTEC campuses.

Students are provided with fire safety information at the annual community health fair, typically held in the Student Service Center. Fire suppression training is provided on a class-by-class basis for training programs where fire suppression is part of the recognized curriculum.

### **Prohibited Items:**

Residence Hall residents are not permitted to have cooking devices generating heat (e.g., hotplates, bread makers, cook tops) or microwave ovens. Residents of Student Housing Apartments are permitted to utilize any residential-type electronic cooking appliance inside their apartment.

Items with an open flame (e.g., candles, incense, tea lights) are prohibited inside all student Residence Halls but are permitted inside Student Housing Apartments when they are directly monitored by the resident.

Other types of items prohibited in or around on-campus housing facilities include, but are not limited to:

- Dangerous, hazardous, or flammable chemicals

- Modified electrical devices with exposed wiring
- Automobile or commercial batteries
- Used car or truck parts
- Other items deemed unsafe by AVTEC Administration, Residence Life staff or the Seward Volunteer Fire Department.

## **Smoking Policies:**

All AVTEC facilities, entrances and vehicles are smoke-free in accordance with State of Alaska law. Smoking, including the use of E-cigarettes and vaping devices, is permitted only in designated areas on campus. Students who are observed to have used smoking devices or substances in undesignated areas are considered policy violators and subject to disciplinary sanctions.

## **Fire Evacuation Procedures:**

1. As part of orientation, residents are encouraged to learn the location of emergency exits and fire alarm pull stations closest to their housing assignment.
2. In the event a resident smells smoke or discovers a fire, they should activate the fire alarm pull station. Students who can evacuate should not attempt to fight a fire but are encouraged to assist other occupants in the evacuation process.
3. When the fire alarm sounds, all building occupants must leave the building immediately through the nearest safe exit. After evacuating the building, occupants will proceed to the designated assembly point. Individuals who have evacuated may not attempt to re-enter the building until told it is safe by Residence Life or Fire Department staff.
4. When the fire alarm is activated or there is reason to believe there is a fire, building occupants should not utilize any elevators.
5. When the fire alarm is activated, before entering another room, residents should feel the door for heat. In the event an individual finds a door is hot or smoke is present through the opening, they should not open it. If a building occupant cannot reach another exit, they should keep the door closed and seal off any cracks.
6. If a resident is evacuating and finds a door cool to the touch, it may be opened slowly with caution and be ready to slam it shut if the area on the other side has smoke, fire, or pressure.
7. When an occupant is trapped by smoke or fire at the exit, they should call 911 and give their exact location. If a resident is unable to exit and does not have access to a phone, they can signal for assistance from a window using a visible item such as a pillowcase or sheet. Residents should not attempt to exit the building by jumping from windows; the Seward Volunteer Fire Department will provide safe evacuation assistance.
8. Occupants caught in smoke or heat should stay low where air is clearer, while taking short breaths through their nose until they can access a safe exit or place of refuge.
9. Fire Doors are designed to close automatically when the fire alarm sounds. If a resident discovers a problem with one of these doors or any other aspect of the fire alarm / suppression system (pull stations, smoke detectors, sprinklers, fire extinguishers, etc.), they should inform an AVTEC staff member immediately.
10. Residents who need special accommodation to be alerted to fire alarms (visual cues, etc.) or special assistance to evacuate the building should inform an AVTEC staff member as soon as they arrive on campus.

## Reporting of fires:

All fires in or around AVTEC facilities are reported to the AVTEC Department Head responsible for the facility in question. The Department Head will notify the AVTEC administration and the Residence Life Department Head for the purpose of reporting the fire in the annual Fire Safety Report.

## Improvements:

As of September 2025, there are no improvements currently scheduled or underway to any of the fire safety alarms or devices on the Residence Life Campus.

## Statistics / Fire Log:

During the calendar years 2008 - 2018 and 2020 – 2025, there were no reportable fires in any of the student housing facilities on campus.

In CY2019 there was one incident of attempted arson in a common area of a student housing apartment building. This incident caused minimal damage and was unsuccessful in starting a fire. Evidence of this incident was observed after the individual responsible was evicted from the housing assignment for unrelated reasons.

The Residence Life Department maintains a Fire Log for all AVTEC campuses. This log documents all reported fires occurring in or around AVTEC facilities. The Fire Log can be viewed upon request at the Residence Life Office, located at 516 3rd Avenue, Room 103, Seward, Alaska. Events recorded in this log are also published annually in the AVTEC Fire Safety Report.
